Ms. Caldwell distributed watercolor paintings of the birds at Green Pond Marsh. She said she believes it is illegal to destroy wildlife and would like to

see the birds protected.

RONALD MORGAN 5725 GREEN POND RD. Mr. Morgan said he loves the birds. He also said he is concerned that the

current infrastructure cannot handle any more traffic.

Mrs. Sawyer-Glagola asked if questions would be taken after the presentation by Traditions of America. President Zawarski remarked that Traditions of

America is only here to review the waivers requested.

MELISSA DAVIS 4282 WINDSWEPT DR. Ms. Davis said the Traditions of America project has still a long way to go before they plan can be approved and feels the Board should wait before approving the waiver requests. Ms. Davis said that concerning the Public Comment item on the agenda, residents are entitled to express their opinions

and be heard.

BARRY ROTH 4323 CHETWIN TERR. Mr. Roth suggested to the Board that a traffic study be done on Ohio Street since it is a cross street with lots of traffic. Mr. Roth believes that cost of the bathrooms at the North Forty is extravagant and that the Bulldogs should pay for this. He also believes the township parks should not be monopolized by one organization.

MARTIN COMER 3613 DEWALT ST.

Mr. Comer believes the money for the North Forty bathrooms would be better served elsewhere in the township. He also stated that residents need to be allowed to speak during public comment.

ROY ROTH 4323 CHETWIN TERR. Mr. Roth believes too much money is being spent on the North Forty bathrooms. He said money should be spent on township parks such as Chetwin Terrace playground.

WAYNE KRESGE 4349 CHETWIN TERR. Mr. Kresge said money should be spent to fix the water run off on Chetwin Terrace and not the North Forty bathrooms.

BILL BERRY 3505 DARTMOUTH DR. Mr. Berry commented on the Public Comment policy. He said people should be responsible and reasonable and be allowed to speak. Mr. Berry also said that people should be gaveled down when they speak out of turn.

BOB BIRK 3766 CHRISTIAN SPRINGS RD. Mr. Birk said nothing seems to be getting done and believes that too much money is being spent on the North Forty bathrooms.

Upon motion (Breslin-Nolan), the Board of Commissioners voted unanimously by voice vote to approve Resolution R025-15 awarding the contract for the Cold-In-Place Road Recycling Project to Recon Construction in the amount of \$156,650.00.

## A RESOLUTION GRANTING CONDITIONAL APPROVAL OF THE PROPOSED ST. LUKE'S HOSPITAL AND HEALTH NETWORK MEDICAL OFFICE BUILDING

Nathan Jones, Planning Director said the plan is for a 3 story medical office building and that the Planning Commission looked favorably on this. Mr. Hudak said that he is impressed with the plan and thanked St. Luke's for

working with the township.

Upon motion (Hudak-Barnard), the Board of Commissioners voted unanimously by voice vote to approve Resolution R024-15 granting conditional approval of the proposed St. Luke's Hospital and Health Network Medical Office Building.

## A MOTION APPROVING A POLICY REGARDING PUBLIC COMMENT AT REGULAR MEETINGS OF THE BOARD OF COMMISSIONERS

Mr. Nolan said that to create this policy will have more negative than positive results and preferred to table it at this time. Mr. Hudak said this is not a means to curtail the meeting but a safeguard against people speaking out of turn.

Upon motion (Hudak-Nolan), the Board of Commissioners unanimously voted by voice vote to table the motion approving a policy regarding the public comment at regular meeting of the Board of Commissioners.

# A MOTION APPROVING THE REQUESTED WAIVERS BY TRADITIONS OF AMERICA FOR THE PROPOSED GREEN POND PRD DEVELOPMENT, AS RECOMMENDED BY THE BETHLEHEM TOWNSHIP PLANNING COMMISSION

David Biddison and Tim McCarthy of Traditions of America gave a presentation of a plan for 261-home development next to Green Pond Marsh. Mr. Biddison said they are seeking approval for the requested waivers and deferrals as recommended by the Planning Commission.

These waivers and deferrals are granted as depicted on the plans presented to the Board by the Applicant:

- -A waiver from the SMO is granted from requiring the design and installation of emergency spillways.
- -A waiver from street design standards as per SALDO 230-57.F(1) is granted in favor of 28 foot wide main streets and 26 foot wide secondary streets, as depicted on the plans.
- -A waiver from street design standards as per SALDO 230-57.F(1) is granted for relief from minimum centerline radius of horizontal curves of 2 streets, as depicted on the plans.
- -A waiver from the requirement of sidewalks on both sides of interior streets of the proposed development is granted in favor of the walking trail system and sidewalks in the development, as depicted by the Applicant.
- -A deferral is granted for the requirement of sidewalk and curbing on Church

Road and Farmersville Road, whereas a waiver is granted from the requirement of sidewalk and curbing on Green Pond Road, as depicted by the Applicant.

Upon motion (Hudak-Breslin), the Board of Commissioners voted by roll call vote to grant waivers and deferrals based upon the recommendation of the Bethlehem Township Planning Commission and the discussion of the tonight's meeting. The motion passed 3 to 2. (Mr. Zawarski, Mr. Hudak and Mr. Breslin in favor) (Mr. Nolan and Mr. Barnard opposed).

#### **DISCUSSION ITEMS**

## POLICE ACCESS DRIVEWAY

President Zawarski said that PennDOT has approved the Highway Occupancy Permit for driveway access onto Easton Avenue from the Police parking lot. This was an unbudgeted item but we can absorb the paving cost of approximately \$5,000 into the Road Materials line item. All design work for this project was done in-house by our Public Works Dept. Mr. Hudak said he is happy that the project is moving forward. No action taken.

#### WARD MAP – AUTHORIZATION TO SEND TO BOARD OF ELECTIONS

Solicitor Broughal said that after the 2010 Census, the wards were deemed unequal and that the proposed map divides the wards equally and fairly.

Upon motion (Nolan-Hudak), the Board of Commissioners unanimously voted by voice vote to authorize the Township Solicitor to send the proposed ordinance and map to the Northampton County of Elections for review.

### EASTON AVENUE CULVERT REPAIR

Solicitor Broughal said they have a conducted a title search and found that PennDOT testified that they constructed the culvert. He asked the board to consider four options: One, the township do the repair themselves. Two, require property owners to fix it. Three, the township fix the culvert and charge the owners. Four, take the matter to PennDOT.

Upon motion (Nolan-Hudak), the Board of Commissioners unanimously voted by voice vote to rescind the action taken at the previous meeting based on the results of a title search done by the Township Solicitor and authorized the Township Manager to take the matter to Penndot.

#### **ADJOURNMENT**

There being no other business, upon motion (Nolan-Hudak), the Board of Commissioners unanimously voted by voice vote to adjourn the meeting at 9:30 p.m.
