The seven (7) day notice will be the ONLY notice sent regarding additional amounts owed.

The Owner/Agent agrees to comply with all BTMA standard specification for construction of Bethlehem Township sanitary sewer extensions, most revised edition.

I the Owner/Agent do hereby agree to the above conditions, and I hereby declare my intent to comply with all BTMA specifications, and financial obligations pertaining to this sewer extension. I agree to pay all applicable BTMA charges as identified by this agreement, all tapping fees, connection fees, and customer facility fees as identified in the BTMA final plan approval Certificate.

I also agree to post the required project surety with Bethlehem Township as identified by the Bethlehem Township Planning Division.
